- Provide assistance to GSVPIP in the development and implementation of SOPs, processes, workflows, referral pathways and operational tools related to vulnerability;
- Provide assistance to GSVPIP in monitoring the implementation of its projects and activities, including program evaluation and quality improvement efforts;
- Provide assistance to GSVPIP in cooperation and liaison with other services and actors, ensuring the coordination of activities related to vulnerability;
- Participate in meetings and liaise with internal and external stakeholders;
- Attend and contribute to thematic, coordination or other meetings and workshops organised by MoMA, EUAA and/or other actors at central level, that aim to enhance and harmonise activities, procedures, and tools on vulnerability issues;
- Be available to participate in missions, as per the operational needs of EUAA;
- Attend regular meetings with EUAA;
- Participate in trainings organised by EUAA or other stakeholders, when requested;
- Provide to EUAA regular analytical and statistical reports of provided services, challenges faced and best practices observed;
- Draft documents, templates, minutes and reports;
- Perform any other tasks in the interest of the service, relevant for the specific profile.
