The Physiotherapy Department promotes applied research, giving appropriate scientific background in conjunction with professional training. Physiotherapy contributes to the promotion and prevention of public health providing services in Hospitals and Clinics, in the Industry, in Rehabilitation Centres, in Care Units, in Thermal Springs, in Sports as well as in the private sector as in Physiotherapy Laboratories, in daily Care Units for persons with special needs as well as in at home visits.

5.1 Access to further study:

The degree provides access to postgraduate studies leading to a Master's (2nd cycle) or doctoral (3rd cycle) degree.

5.2 Professional status (if applicable):

The title of study leads to a legislatively guaranteed profession. The graduates of Physiotherapy Department of the Faculty of Professions of Health and Providence of Technological Educational Institutions (TEI), bring the professional title "Physiotherapist". They are occupied either autonomously or in collaboration with doctors, after the relative medical diagnosis, with the prevention, improvement and rehabilitation of pathological conditions as well as body damage that causes disorders in human systems like muscular, nervous, respiratory, cardiovascular etc. The Physiotherapist treats after the written doctor diagnosis. Physiotherapy treatments are the methods and techniques taught at the Physiotherapy Departments of TEI. Physiotherapists work in both public and private sectors. They can operate their own Physiotherapy Laboratories, after obtaining a work permit.

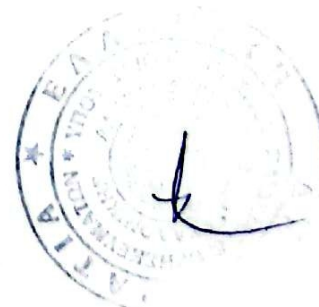

According to the Framework Law (2001), higher education consists of two parallel sectors: the University sector (Universities, Polytechnics, Fine Arts Schools, the Open University) and the Technological sector (Technological Education Institutions (TEI) and the School of Pedagogic and Technological Education). There are also State Non-university Tertiary Institutes offering vocationally oriented courses of shorter duration (2 to 3 years) which operate under the authority of other Ministries.

(i) Structure
According to the Framework Law (2001), higher education consists of two parallel sectors: the University sector (Universities, Polytechnics, Fine Arts Schools, the Open University) and the Technological sector (Technological Education Institutions (TEI) and the School of Pedagogic and Technological Education). The same law regulates issues concerning governance of higher education along the general lines of increased participation, greater transparency, accountability and increased autonomy. 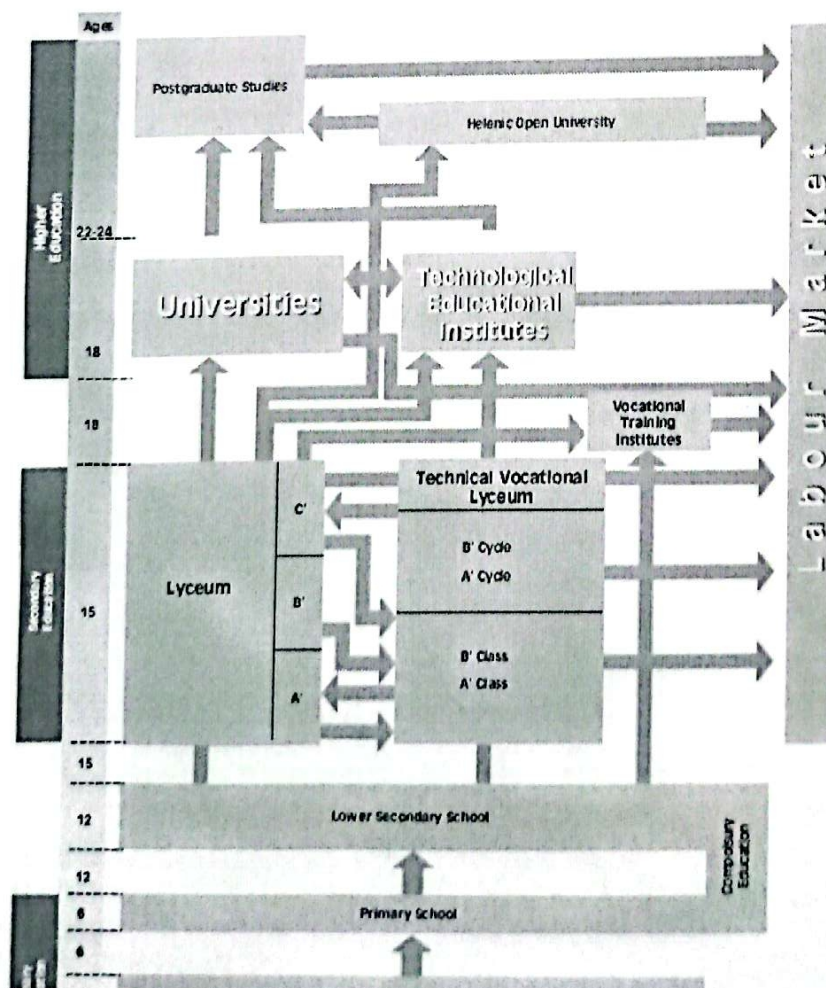

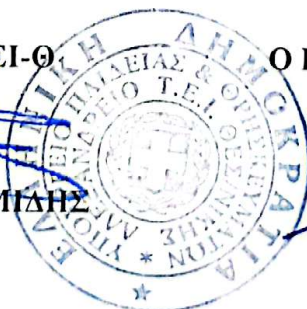
