Dear Doctor:

This will acknowledge receipt of your letter concerning your eligibility for an ECFMG certificate.

Since the time you passed the medical science examination and English test, the documentation and verification of your medical education credentials has been completed and you are now eligible to receive a Standard ECFMG Certificate.

Because the certificate must be printed, it will take approximately three to four months to process.

In the meantime, ECFMG will be pleased to verify your certification status to a program director or state licensing board upon receipt of a written request. Verification of your ECFMG certification was sent to the Division of Professional Licensing, Albany, New York on September 27, 1991.

Your Standard ECFMG Certificate will be valid through January 1993 based upon your most recent passing performance on the ECFMG English test.

If you have begun an accredited program of graduate medical education or training in the United States, as soon as possible submit a letter from the program director giving the date you entered the program and the specialty. ECFMG will revalidate the certificate provided that you began the program prior to the certificate's expiration date.

A Standard ECFMG Certificate which is not used for admission to an accredited graduate medical education program prior to the expiration date on the certificate can be revalidated by passing an ECFMG English test or demonstrating performance acceptable to ECFMG on TOEFL (Test of English as a Foreign Language).
